Once approved we will send you a confirmation and an invoice. Places are limited. We cannot guarantee that we can approve every application. Your registration will be successful after we confirmed your place and have received the program fee as indicated below.

Terms and Conditions for the Generative Facilitation Certification Program (GFCP) 2024/2025:

- With this registration for our Generative Facilitation Certification Program (GFCP) 2024/2025 you register for the overall GFCP program including all 5 modules.
The Program fee for the overall GFCP is 5.900,- EUR plus 19% VAT (1.121,- EUR) which is in total: 7.021,- EUR. Vendor Fees by Eventbrite will be charged extra during the booking process. The program fee is due 4 weeks after receiving the invoice, at the latest 2 weeks before the official start date of each cohort.

The GFCP program fee includes:

- Personal 1:1 dialogue interview online to kick-start your learning journey.
- 5 intensive on-site learning modules of 3,5 days each.
- 2 online webinars.
- Personal 1:1 coaching session by a trainer of the GFI faculty online (optional)
- Certification Process in the last module including a demonstration of a live facilitation session and a presentation of a facilitation process design of each participant.
- Training material including tools, practices, reader, handouts and reading lists and resources,
- Personal journal and reflection tool.
- Guidelines for peer learning and coaching in between modules which will be self-organised by the participants and encouraged by the lead facilitator.
- Access to our Generative Learning Community, our GFI Online Learning Platform with access to further resources as well as to a growing international network of generative facilitation professionals.

- We plan to run the **GFCP 2024/25 with an English and German cohort**. You choose below for which cohort you would like to register. **6 weeks before the first module will be the official start date of each GFCP cohort**. You will receive a welcome mail, material for your preparation, access to our online learning community and an invitation for a **personal dialogue interview** to be held before the first module. It is intended to support you for having an optimal learning experience and start into your learning journey.

Dates for the webinars will be communicated at the start of the curriculum.

We recommend to plan for 6-8 extra hours between each module for personal preparation and application, (peer) coaching and deepening of the material.

3. **Cancellation policies** are as follows: In the event that you need to cancel your participation in the GFCP, the following policies apply:
- Up to 10 weeks before the start date of your registered GFCP cohort we offer a full refund of the program fee minus a handling and service fee of 280 EUR plus VAT and any banking or vendor (Eventbrite) fees involved.
 - Up to 6 weeks before the start date of your registered GFCP cohort we offer a 50% refund of the program fee.
 - For cancellations after 6 weeks before the start of your registered GFCP cohort we cannot offer any refunds due to made arrangements. In this case you can present a suitable participant as your replacement where we would need to check if the respective fit would apply.

In the event that you cannot participate in one specific module of your cohort we can check the possibility and availability of a free spot in the parallel cohort of the same year for you. We cannot guarantee a free spot.

In the event that we as GFI need to cancel the overall GFCP (with all 5 modules) we will fully refund your rate in case that the new dates do not work for you. We as GFI are prepared to run modules as online modules or shift dates of certain modules where needed (i.e. due to illness, COVID-19 restrictions etc.) in order to secure a smooth flow of the overall GFCP. We cannot cover any expenses or cancellation costs involved on your side (i.e. cancellation fees for transport, accommodation etc.).

4. The GFCP will be conducted by one lead trainer of the **GFI faculty**. In key areas of expertise one additional trainer and expert of the GFI faculty will participate in sessions of certain modules or webinars. The lead trainer and guest faculty can be replaced in case of any given circumstances (i.e. in case of illness, travel restrictions etc.) in order to secure the smooth flow of the overall program.
5. The **training language** will be English in the English cohort and German in the German cohort. **Online access to training material other than the training language of your cohort** (i.e. access to English material for German cohort and vice versa) can be offered as **basic package** including the GFCP tools and practices for an extra 290 EUR plus 19% VAT and the **inclusive package** including GFCP tools and practices, GFCP readers and reading lists as well handouts for an extra 350 EUR plus 19% VAT.
6. The **training location** will be Berlin, Germany, if not otherwise indicated. We will inform you on the exact training venue after your registration.
7. **Organisation and costs for travel, lodging, beverages and meals are excluded and will be covered and organized by each participant.** We can assist you by sending a list with respective hotels close to the venue. We recommend that you make an early reservation with the hotel of your choice. The costs for the training venue including coffee and tea breaks for each onsite module (**venue package/Tagungspauschale**) will be charged separately and range from 230 to 250 EUR plus 19% VAT per module. The respective invoice will be sent out before the start of the first module.
8. We honor the **privacy of your data**. Customer data is stored to internal settlement and clearing and information purposes.
